# The Vestuary-Book of the Irish Dominicans in Rome, 1727-1796

Hugh Fenning, O.P.

In one respect the twin-convents of SS. Sixtus and Clement are well-nigh unique among the many colleges owned by Irish religious on the continent: their domestic archives have come down to us virtually intact.<sup>1</sup> One may still read the house-council book, the opening pages of which were written even before the Irish Dominicans took possession of the two convents in 1677.<sup>2</sup> The book of receptions and professions begins in 1676, the vestuary book in 1727, and the account-books in 1730, while the first *Liber de Ratione Studiorum* covers the academic side of the community's activities from 1743 to 1788. Although not quite complete, these records are of the greatest importance for the history of the community as such. Incidentally, when one considers the general poverty of our sources, they are relatively rich in biographical information. From this point of view the first vestuary-book is probably of the greatest general interest.

The strange title of the volume derives from the custom whereby twice a year<sup>3</sup> the professed members of the community were given an allowance of four *scudi*, ostensibly to buy habits.<sup>4</sup> The allowance was called their vestuary, and each member of the community (on receipt of the allowance) had to sign the vestuary-book kept solely for that purpose. The first volume opens with the payment made at Easter 1727 and closes with that for Easter 1796. It is a tall, narrow

ledger (33×11 cm.) of 90 unnumbered leaves, bound in vellum. The various entries, all of which are in Italian, follow each other in chronological order, covering both sides of each leaf. Only the last three leaves are blank.

My first impression was that the present volume was merely the second or third in a series of vestiarium-books going back to 1677, and that it was the earliest only in the sense that it was the oldest to have survived. That does not seem to have been the case. On 8 July 1726 it was decided at a meeting of the house-council that in future each priest should be given a Mass-stipend every week so that he could provide himself with shoes and stockings, towels, and a biretta, besides paying for his own tobacco and letters. The money would be held by the bursar until the priests of the community needed it.<sup>5</sup> The arrangement cannot have been a success. The few members of the community who, although professed, were either laybrothers or clerics, would have found themselves at a disadvantage, all the more galling because they had no voice in the council's decision. There was another difficulty in that the allowance was forfeited *toties quoties* whenever a priest omitted to celebrate Mass on any day in the week. In the course of a few months the community turned to the Master General, who handed down his ruling on 15 February 1727. Each member of the community was to be given eight Roman *scudi* a year "*per modum vestiarii*".<sup>6</sup> This command satisfactorily explains why the vestiarium-book begins at Easter 1727, and strongly suggests that it was the first such record kept by the Irish Dominicans in Rome.

The biographical value of the volume consists in the fact that it identifies the professed members of the community between 1726<sup>7</sup>

and 1796, gives more or less precisely each individual's period of residence, and enables one to estimate the size and composition of the community at any given time within those limits. The names of those who formed part of the community only for their novitiate year do not, however, occur in this record at all. Their names may be found in the register of those received to the habit: there were rarely more than one or two such novices in the house. Although the regular payments were made only twice a year they were calculated with some exactness, so that the first and last allowances received by any member of the community were estimated to the very day of arrival or departure. One can therefore in many cases determine a member's date of arrival from the amount given to him at the end of a semester. Sometimes those leaving the house, on signing the vestiary-book for the last time, would also note the sum given to them as a viatick: occasionally they named their destinations and thus enhanced the value of the record.

Unfortunately the book was not always kept as exactly as it should have been. Many who received the payments did not sign for them. The exact period for which payments were made was not always noted. From 1779 one finds only a list of names under the general headings "Maggio" or "Novembre", no note being then taken even of the sums granted to the brethren. For this reason I have tried to amend the record with the help of the account-books, since the vestiary payments always figured as part of the expenditure in the syndic's accounts. Here too there are difficulties, for the accounts themselves were not consistently well kept, but the reader may judge for himself the great value of the account-books as a complement to the vestiary-book. In the list which follows everything within round brackets is based on vestiary payments noted in the accounts. Significantly, this exercise in "restoration" has brought to light eight members of the community who certainly received their allowance but whose names do not occur in the vestiary-book at all. In many other cases it has considerably enlarged the period of residence as known from the vestiary-book and given more precise details in regard to the destination of those leaving the house.

The method adopted in presenting the text has been simply to list the various members of the community in the (roughly chronological) order in which they make their appearance in the book. After each name is given the period of residence as calculated from the amount and date of payment. Whatever is in round brackets has been taken from vestiary-payments noted in the account-books of the house. Only one element of biographical interest has been

omitted: although occasionally individuals signed themselves as “prior”, “master of students”, etc., such indications have been ignored in this edition. Their occurrence is so infrequent that it would be awkward and unsatisfactory to include them.<sup>8</sup> The succession of priors (to 1777) is already in print,<sup>9</sup> and there are other convent records which enable one to establish complete lists of lesser officials, whether of the house or *studium*. Since the entire community, from prior to brothers, consistently gave themselves only the prefix “fra”, there is no indication as to which of them were priests: in this respect the published Roman ordination lists are of some assistance.<sup>10</sup>

Here then is the record itself. Containing as it does the names of one hundred and sixty Irish Dominicans, there can be no doubt of its value for the history of that Order. Outsiders may be more interested in the information it offers on the first two bishops of New York (Concanen and Connolly), a famous archbishop of Dublin (Troy), some lesser Irish bishops such as Burke of Ossory, MacDonogh of Kilmore, and Brett of Elphin and Killala, as well as a host of others who served the Irish people during the penal times.
